The Lead Managers will be paid a 2% management fee and a 4% capital raising fee in cash. The management fee is to be calculated on the total gross amount raised under the placement while the 4% capital raise fee calculation will not include the funds raised from Oaktree, the company's largest shareholder. Approximately \$4.25 million is to be contributed by Oaktree.
