## Section 708A Cleansing Notice

This notice is given by EQ Resources Limited (**EQR** or the **Company**) under Section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Corporations Act**).

The Company hereby confirms that:

- (a) On 10 March 2026 it issued 5,543,029 fully paid ordinary shares (**Shares**), 2,500,000 from the exercise of options at an issue price of \$0.07 (7.00 cents), 1,851,853 from the exercise of options at an issue price of \$0.0675 (6.75 cents), and 1,191,176 from the cashless exercise of options issued to eligible persons under its Employee Incentive Plan;
